


The bar graph illustrating the breakdown of the \$28,225 expenditure during the 2020 COVID crisis. It highlights the different categories of spending and their respective amounts.



DETAILED EXPLANATION OF EXPENDITURE AND IMPACT OF COVID-19

Sheltering (26.57%): The pandemic created a heightened need for stable and safe shelter for vulnerable children and women. Despite reduced donations, providing a safe environment remained a top priority, especially given the increased risks of homelessness and abuse during lockdowns. Shelters had to accommodate more people and follow COVID safety protocols.

Feeding (24.09%): Feeding 48 children every day required a substantial portion of the budget. With schools closed, the children relied on the shelters for all their meals—breakfast, lunch, and dinner—putting additional strain on resources. Securing food became more challenging and expensive as supply chains were disrupted, making feeding programs even more crucial.

Health Care (17.71%): The health conditions of children with sickle cell anemia, HIV/AIDS, and other chronic illnesses demanded constant care. COVID made it harder to access medical services, and with a higher health risk to these children, funds were directed toward ensuring they received necessary medications, checkups, and emergency treatment.

Administrative Work & Funds (3.54%): Administrative expenses such as maintaining records, managing reports, and purchasing stationery were reduced to focus on core activities like sheltering and feeding. Nevertheless, this category remained essential for ensuring the smooth operation of the charity, even with minimal staffing.

Advocacy (1.77%): Despite the pandemic, advocacy efforts continued, particularly in coordinating with law enforcement, probation officers, and partner organizations to address cases of child abuse and family distress. This small but essential part of the budget ensured that advocacy for children's rights did not stop.

Tutoring at Shelters (4.25%): With schools closed due to the pandemic, shelters became the primary learning environment for children. Tutors were brought in to ensure that learning did not halt. This allowed the children to continue their education and build skills despite the disruptions caused by the pandemic.

Building & Restoring (13.82%): Even in the midst of the crisis, the charity managed to build a house for one family, ensuring they had a stable and secure place to live. The pandemic magnified the need for housing security, and this project was a significant achievement in a difficult year.

Emergencies (4.25%): Emergencies were frequent, particularly involving sick women and pregnant teens who needed urgent medical care. COVID heightened the vulnerability of these individuals, and funds were allocated to address their immediate needs.

Transportation (2.21%): Moving goods, food, medical supplies, and staff during the lockdowns required special arrangements. Despite travel restrictions, the organization had to ensure that resources reached the shelters and that staff could commute to provide care.

Facilitation for Workers (4.46%): A small staff of essential workers—cook, tutor, and security guard—were paid modest salaries to ensure the continued operation of the shelters and care for the children and women. This was critical for the daily functioning of the shelter during the pandemic.

Women Care & Food Packages (4.39%): During the COVID crisis, the charity provided 54 women with monthly food packages, ensuring they had the necessary sustenance during lockdowns. Each woman received \$20 worth of food and basic supplies, crucial for survival during a time when many lost their income sources.

IMPACT OF COVID-19 ON DONATIONS AND PROGRAMS

The COVID pandemic severely impacted donors, many of whom faced economic hardships and were unable to contribute as generously as in previous years. As a result, the organization saw a significant reduction in funding. This led to the scaling down of many programs and a focus on core activities like sheltering, feeding, and health care. Fewer and smaller programs were conducted due to the strain on resources.

Sheltering, feeding, and healthcare took the largest share of the budget because these were essential for the survival of the children and women. With limited funds, the charity had to prioritize basic needs and put non-essential or long-term programs on hold. Despite the challenges, the organization adapted by cutting costs, streamlining operations, and continuing to provide critical support to the most vulnerable during the pandemic.

APPRECIATION REMARKS.

As we close the financial year 2020, we reflect on the challenges and triumphs we've faced together. The pandemic brought uncertainty and hardship, but through it all, your support enabled us to remain steadfast in our mission to protect and care for vulnerable children, mothers, and families. Every contribution—whether it was shelter, food, health care, or educational support—has had a profound impact.

We scaled down some programs due to financial constraints, yet the resilience and hope that emerged from our community is a testament to God's faithfulness. In Matthew 25:40, Jesus reminds us, "Truly I tell you, whatever you did for one of the least of these brothers and sisters of mine, you did for me." Your giving and sacrifice have been a living example of this verse, extending God's love and grace to those most in need during one of the hardest times in recent history.

Through your generosity, we were able to provide shelter for those with nowhere to go, feed the hungry, care for the sick, and continue advocating for justice. You have been the hands and feet of Christ, and we are profoundly grateful for your partnership.
